

Recommendations:

ITEM #1:

Entries removed from shopping cart after order button selected

Had problems when product was not successfully delivered

Had to perform query again to place back into cart to reorder

ITEM #2:

Requirement was to order full frame imagery

To reduce size wished to chip only portion of image that applied


Currently requires one to type in the upper right/lower left coordinates

Not User Friendly - Wish to graphically define region

Major Findings:

ITEM #1:

Could not generate IESS Reports

Observations:

ITEM #1:

For those sources connected that require login/passwords, identify minimum read, write, execute permissions

ITEM #2:

Stability

Beta II Testing (JFCOM)

Major Findings:

ITEM #1:

Allow a local site administrator the ability to limit access to remote sources (same as v2.0)

ITEM #2:

If the number of sources that a user is allowed access to is changed, the sources that users have selected for querying could change

ITEM #3:

Removal of an account in a CSE Broadword interface should remove (1) all of the user's roles, (2) all of the user's access to sources not available to other users on the system and (3) all of the user's batch, update notification and saved query files

ITEM #4:

The ISSO Audit log function seems to fail an inordinate amount of the time. Accessing the ISSO logs after the fact will show that the user successfully queried the audits, but they never display on the client

ITEM #5:

Generating audits and archives took a long time.
